

DISCOURAGED ENGINES By D.E. Matt

In spite of Trump's optimistic campaign promises on coal, Edgemont's coal train engines don't seem to be engines that "think they can."

More than 100 engines have been sitting idle for days and days amid ongoing rumors of coal market uncertainty. Two trains composed entirely of indecisive coal train engines have been sitting on two sidetracks in the Edgemont, South Dakota rail yard awaiting who knows what.

Gillette, Wyoming may harbor a reported 300 or more engines and the rail vard in Alliance, Nebraska has similar scenes. Unofficial rumor has it that there may be as many as 5,600 engines sitting idle nationally.

Perhaps these engines have been discouraged by the chaotic aftermath of 2016 including rumors of contention and a possible shake-up in the White House. The engines may have read reports in the Denver Post threatening to tie up coal fired power plants in the courts for years to maintain current clean air standards. Perhaps they were discouraged by graphs showing years of a downhill price slide for competing clean burning natural gas.

A TALE OF THREE CITIES By Frank Gregg

Edgemont, South Dakota has gone through several stages of boom and bust over the course of its lifetime and its boundaries have changed in the process. No one, however, could have foreseen how those boundaries have wandered over the map as they appear now.

First. a little history.

South Dakota's first rail lines were laid in the 1870s and played an important part in the settlement of the state. Programs were instituted by the railroads to encourage settlers to move into new territories and were prominent in the economic and social structure of the state.

In many cases the railroads platted town sites to sell to new arrivals settling the area and in large part defined the population areas of the state. Edgemont was one of those towns. In many cases, the towns themselves were a profit center for the railroads.

In 1889 the Chicago Burlington & **Ouincy** (CB&O), or The Burlington, built through the southwestern corner of the state and decided to use this route to expand into the Black Hills.

Prior to that expansion, the Black Hills and Fort Pierre Railroad as well as the Deadwood Central had been built through the hills, but were not connected to a main line. The Burlington quickly bought out those lines and extended into the Black Hills with both standard and narrow gauge rails.

South Dakota was admitted to the Union the second of November, 1889, three days before the railroad arrived in what would be known as Edgemont. The Lincoln Land Company, a subsidiary of the renamed Chicago, Burlington and Missouri Railroad, determined that the Cheyenne River was an appropriate spot for a depot because a supply of water was available for the steam locomotives.

According to the Edgemont Chamber of Commerce, the land company was forced to purchase land south of the river as the price was too high on the north side.

In the spring of 1890, the rail yards were built and the town of Edgemont was born. The town name was derived from the fact that the town was located on the southern edge of the Black Hills. The town was platted and houses, churches and bars were built. *(see Cities on back cover)*

Standing Rock: Is the Profit for a Few Worth the Risk for Many?

We need to look at all of the facts about Standing Rock, not just the incomplete stories published by mainstream media, and weigh them against the cost to human lives and to our vital resources. Ask yourselves, "Is the profit for a few worth the risk for many?"

Energy Transfer Partners, the Dallas-based corporation that built the pipeline, continues to insist that it is safe. Accumulated evidence, showing multiple and continuing oil pipeline leaks across the country, says otherwise. Landowners and others living in the vicinity are worried about damaged pipes spewing oil onto their lands and endangering their water supplies.

The fracking process used to extract the oil turns it into a toxic substance. When a spill occurs, these toxins further add to the contamination caused by the oil to the surrounding land and water. Also, according to U.S. statutory law, it is illegal to transport this toxic substance across the country.

Oil is a valuable resource; however, when transporting it, consideration for our environment and the welfare of those living in the vicinities must be a priority. Every effort should be made to ensure the safest mode of transportation is used to fully protect vital water resources.

The original route of the pipeline went by Bismarck, ND. It was rerouted due to potential danger to the drinking water supply of the Bismarck people. Its new route is near Standing Rock where it will threaten the drinking water supply of the Lakota people.

Trash was left behind at Standing Rock, but it was not from the "water protectors." Instead it was trucked in by Morton County to make it appear that the protectors were intentionally making a mess. Some people complained about ceremonial fires set at the encampment when the protectors were forced to leave. But where is the outrage to the brutal treatment to which many of the protectors, including elders and children, were subjected? Prosecutors and judges have dropped 33 misdemeanor cases that had been filed against Standing Rock protectors. Another 14 were resolved by guilty pleas. Most of the cases related to criminal trespass charges from late last summer and fall.

Water protectors and demonstrators had spent months at the Standing Rock Reservation trying to stop the \$3.8 billion-dollar, four-state pipeline. The major concerns continue to be that a spill would contaminate the drinking water for the reservation and construction of the pipeline would damage sacred Native American sites, the latter of which has already occurred.

This is not a racial issue. Water is a resource needed by us all.

Abundance of Evidence Proves the Increasing Dangers of Vaccines

Native Voices: Origins of the Lakota/Sioux

The name "Lakota" means "allies, friends or those who are united." Dakota originates with the word Da meaning "considered" and Koda or "friend." The name Sioux is Algonquin. It comes from Nadowe Su, which means "Little Rattle." It pertains to the rattling sound that a snake makes before it strikes. The spelling was changed from Su to Sioux by French traders and trappers who also dropped Nadowe.

The Lakota or Sioux are also known as Teton ("prairie dwellers"). Teton Sioux are part of a confederation of seven related Sioux tribes or Seven Council Fires (Oceti Sakowin).

The Lakota language is spoken, which is the westernmost of the three Siouan language groups, occupying lands in both North and South Dakota.

There are seven bands or "sub-tribes of the Lakota. These include: Sichangu (Brule, Burned Thighs), Oglala ("They Scatter Their Own"), Itazipcho (Sans Arc, Without bows), Hunkpapa ("End Village" Camps at the End of the Camp Circle), Mnikhowozu ("Plant beside the Stream", Planters by the Water), Sihasapa ("Black Feet"), and Oohenunpa (Two Kettles).

The Sioux language overall has three dialects: Lakota, Dakota and Nakota. The main dialects today are Lakota and Dakota, with the Nakota being the least frequently used. Dialect speakers are easily understood by each other. Most Lakota, Dakota and Nakota people live on South Dakota's nine reservations. Sioux reservations also exist in North Dakota, Nebraska, Montana, Minnesota and Canada.

The Siouan language speakers most likely originated in the lower Mississippi River region and migrated from there to the Ohio



valley. They may also have been part of the Mound Builder civilization during the 9th-12th centuries CE. They were agriculturalists and by the late 16th and early 17th centuries, Dakota-Lakota speakers lived in the upper Mississippi Region in the present day states of Minnesota, Wisconsin, Iowa, and the Dakotas.

Eventually the Lakota were pushed westward to the Great Plains in the mid-to late-17th century by conflicts with the Anishnaabe and Cree peoples. After the introduction of the horse to the continent, they became skilled horsemen and relied mainly on the buffalo for sustenance.

This great nation of respected elders, warriors, women and children were selfsustaining and lived in balance and harmony with consideration for the environment which provided for their needs. Paha Sapa, the Black Hills, were considered to be *sacred* and used mainly for ceremonial purposes.

The beautiful Hills remained in near pristine condition until the intrusion of gold prospectors in the 1800's. According to the Fort Laramie Treaty of 1868 the Black Hills were to remain the sole domain of the Lakota people in perpetuity or "as long as the grass shall grow and the rivers will flow."

With the discovery of gold, Lt. Col. George Armstrong Custer invaded the Hills with 1,000 soldiers in 1874. This led to the Battle of the Little Big Horn in 1876, a victory for the Lakota. Soon though, they were forced onto present day reservations including Pine Ridge, Rosebud and Standing Rock. Stripped of their land and way of life, the people of Pine Ridge now constitute the poorest county in our nation.

Doc Middleton – Gentleman Horse Thief

This formidable country we live in spawned many notable characters, but none quite as colorful or controversial as James Middleton Riley, aka Doc Middleton.

Born in Bastrop, Texas in 1851, Doc got into trouble there early on and joined a cattle drive that was headed to Nebraska. The Wild West History Association reported that Doc got in an argument with a soldier in Sidney, Nebraska in a local saloon. The soldier knocked him down with a blow to the face and he got up only to be knocked down again. Then he shot the soldier in the stomach.

Doc jumped on the next stage without his coat. This was in a very cold January. J.E. North gave Doc a buffalo robe to keep warm. Later, when his career of horse thievery began, there was not one horse of the North herd that was lost.

Doc Middleton is sometimes known as "King of the Horse Thieves," reportedly stealing 2,000 head from not only ranches but the Sioux over a two-year period. He claimed that he only stole from Indians and the U.S. Government but the actual truth is unknown.

The "pony gang" that he organized had an elaborate system of taking stolen horses from one select ranch to another. These were spread out all over Niobrara County.

One of my 11-year-old relatives, Ray Barclay, worked for a rancher herding horses. Ray didn't realize it was one of Doc's relay stations. Some mornings he would hardly have any horses to herd and the next morning the corral would be full.

Ray's mother ate at the same table with the notorious outlaw and said he was a very nice looking man and very mannerly. Many people described him as likable, good tempered, sober and industrious. He was never known to drink or gamble, although he later owned saloons in Wyoming, Nebraska and South Dakota.

He had many scrapes with the law but always seemed to get away. He did serve time in the penitentiary in Nebraska but was shown leniency because he almost always protected the white settlers and was thought to only steal from the Indians.

The Indians believed that Doc was favored by the Great Spirit because he had front teeth that were filled with gold. He was known as the "Gold Chief" and they would not kill him.

The famous Buffalo Bill Cody was his friend and Bill hired him for his Wild West Show. In 1893 he rode in the great Chadron to Chicago horse race and didn't win, but finished the race in good time.

One of his charitable deeds involved a little girl who had died, who was held in high esteem in the town of Douglas, Wyoming. Unfortunately, there was no wood to make her coffin in the surrounding area, so Doc actually took the fine polished wood that made up his bar in his saloon to create her small coffin.

Some said Doc had the air of a traveling Methodist preacher with a little bit of Robin Hood thrown in.

Doc was purported to have owned saloons in Ardmore and in Edgemont, where he was also Town Marshall. He would "fill them up and lock them in."

Doc was married several times and had four children. In about 1914 he relocated to Orin Junction, Wyoming and owned a bar there. There was a knife fight over some trivial matter and Doc was severely stabbed in the stomach.

Doc was arrested because of the fracas and was being held in the county jail where infection developed, resulting in his death at the court house a few days later. He is buried in the Douglas, Wyoming cemetery.

Dangers Posed by Uranium Mining

"Caution Radiation Area. Radiation levels in this area are elevated. No more than one day within a one year period should be spent in this area. NO CAMPING."

This is a sign located not in Fukushima or Chernobyl but at Riley Pass Uranium Mine in Northwestern South Dakota.

There are 272 abandoned uranium mines and prospects in South Dakota. There are more than 10,000 unmarked, unfilled abandoned uranium exploratory wells. More than 4,000 of them are in the Southwestern Black Hills. All of these wells have caused the Madison Aquifer, the source of drinking water for many communities, to be contaminated with uranium.

There is no safe threshold for exposure to radiation. Besides causing cancer, radiation exposure can result in childhood leukemia, respiratory and kidney disease, diabetes, miscarriages, birth defects, heart disease, rheumatoid arthritis and other ailments.

Uranium Again?

There was a uranium boom in Edgemont during the 1950's and 1960's. A mining company, Susquehanna Corporation, left behind a 4 million-ton pile of radioactive waste.

Those tailings were used as fill material at 60 locations around town where it emitted radon gas, which was cancer-causing and had to be dug up. It was then buried in a pit, measuring a mile across, just south of Edgemont.

People in town, not only miners and mill workers, suffered lung diseases and various cancers that may have been caused by breathing radioactive dust and gas.

In a 1976 study by the South Dakota Department of Health, cancer rates were higher in Fall River County than in the rest of the state.

Susquehanna left the cost for cleaning up to the federal government and the American taxpayers. The corporation was legally Dr. K. Kearfott, Ph.D., a nuclear physics professor from the University of Michigan, and his team conducted tests in Southwestern South Dakota and found radiation levels higher than in Chernobyl and Fukushima!

The Northern Great Plains, most notably the Pine Ridge Reservation, has the highest rates of cancer in the country, particularly lung cancer. The cancer rates began to increase drastically several decades after the start of uranium mining in their territory. Uranium mining is contributing to the genocide of the Lakota Nation.

Mining exposes uranium to the atmosphere where it becomes reactive. It then releases other radioactive elements, such as thorium and radium, and toxic heavy metals, including arsenic, selenium, mercury and cadmium.

Most recently, the Dewey Burdock project, which had been stopped by the Lakota

dissolved decades ago.

Powertech has been taken over by Azarga Uranium Corporation, an inexperienced uranium mining company, owned by China, with headquarters in Hong Kong.

Will they repeat the mistakes of the past? Even though mining procedures are different now with in situ, or in place, mining, there can be dangers.

According to Dakota Rural Action Fact Sheet (Jan. 2015), Azarga is seeking South Dakota permits for 551 gallons of water per minute from the Madison Aquifer and 8,500 gallons per minute from the Inyan Kara Formation. That's 12.96 million gallons per day for 20 years. The company expects to get this for free.

On March 7, 2017 two EPA permits were passed to Azarga. The project already has a license from the U.S. Nuclear Regulatory Commission. Next, the SD Department of Environmental and Natural Resources has to give final consideration to state permits for the project. Will China really care about water contamination here? Leaks and accidents in these types of operations are ineviand other protesters in 2015, is currently back on the agenda.

Dewey Burdock, a subsidiary of Azarga (a Chinese company), is calling their in situ mining project Powertech.

This project has the potential to make Fall River and Custer Counties, where the mining will take place, a "toxic waste disposal site," says Lindsey McLean, a biochemist and Rapid City businesswoman.

Powertech also has the potential to further contaminate the four basic aquifers that encircle the Black Hills, most notably the Madison Aquifer, the main source of drinking water, as well as the Minnelusa and Inyan Kara Aquifers, used for irrigation, livestock and human use.

Time to speak up again folks! Especially if you want your and your children's future to include healthy and safe drinking water, not to mention a clean environment. And with respect to all the wildlife and vegetation that is dependent upon our choices, we must make good choices to ensure their continued survival in this great web of life.

table. What about flooding and runoff into the Angostura Reservoir and the Cheyenne River? Is containment really possible given the natural fractures and fissures in this region's geology?

We have lived in Edgemont for almost three years now and love the people we have met. Because we are somewhat isolated from larger communities, there are organizations and activities that are delightful and educational. There are many opportunities to serve.

It's the perfect community in my estimation. I don't want to see anything happen that might cause harm to the citizens here or anyone else in these beautiful Black Hills. There are too many unanswered questions. Bottom line: I don't trust China. Six Uranium Myths

Myth #1 – Only engineers can understand Azarga's plan to inject water, oxygen and carbon dioxide underground to get uranium.

The truth: most grade schoolers have cleaned a penny or a nail in the carbonated water known as Coca-Cola. This carbonated water is also called carbonic acid: it is simply carbon dioxide in water. It dissolves metals—including uranium.

Multiple patents using carbonic acid for in situ uranium extraction are available simply by Googling.

Myth #2 – Uranium and carbonated toxins remain harmlessly locked below underlying ground waters.

The truth: Duke University research experiments published on October 26, 2010 showed that placing CO_2 underground for greater than 300 days "could pose a risk to overlying fresh groundwater."

Drinking Water Experts

Thousands of active uranium wells exist at the Crow Butte Resources uranium mine in Crawford, Nebraska, a town of about 1,000. Debra White Plume and other Lakotas, with the support of the Sisterhood to Protect Sacred Water, filed an injunction seven years ago to stop the mining. They are worried about the environmental and health impact resulting from the mining. They are supported by geologists, hydrologists, lawyers and other water experts.

The Crow Butte Resources, or CBR, uranium mine is situated at the base of Crow Butte, a sacred site located within Lakota treaty territories. The situ leach process is being used: water is injected at high pressure into aquifers. The mined uranium is then sent to Canada to be sold.

CBR claimed their operation would be temporary, functioning for no more than 20 years, and that the land and water would be restored to their original conditions. None of this has happened; instead, CBR plans to expand to three new sites.

In hearings last August, Cindy Meyers, a

They further said, "Potentially dangerous uranium and barium increased throughout the entire experiment in some samples." This showed underground storage of CO_2 may not be so harmless.

In addition to natural geologic flaws, Azarga operations would include up to reportedly 4,000 unmarked and uncapped exploratory well holes as deep as 600 feet, as reported by the Culture Change website (http://www.culturechange.org/cms/index. php) in February 2009.

Myth #3 – This is only a small town local issue, affecting very few.

The truth: uranium in groundwater is a growing problem throughout the west, as reported by the Associated Press in the Rapid City *Journal*.

If hearings were held that involved the western half of the country—which is really affected—the results would probably be different.

Myth #4 – Mining bond monies posted would correct any minimal groundwater

rancher from central NE, brought her own water in jars, claiming, "This is what water is supposed to taste like. We call it sweet water." It does not have the chemical taste found in other drinking water, she noted, adding that once water is contaminated it can't be restored. Meyers said pure water is worth protecting at all costs.

White Plume, a grandmother from the Pine Ridge Reservation in South Dakota, shares the view held by the Lakota that water is sacred. She said 10 years ago she began to see a rise in illnesses and premature deaths on the reservation. Wells tested showed high levels of radiation, arsenic and lead. She deduced the connection between local contamination and the CBR uranium mine located near the reservation.

White Plume and others filed to prevent the Nuclear Regulatory Commission, or NRC, from renewing mining permits. The Atomic Licensing Board has jurisdiction over the NRC. The Board reviewed nine contentions, including the lack of scientific evidence used in the permit application; the contamination of rivers and aquifers; connections between the mine and the nearby Pine Ridge Reservation; insufficient cultural surveys and consultation with the damage.

The truth: a U.S. Geological Survey study by Otton in 2009 said, "to date, no remediation of an ISR operation has successfully returned the aquifer to base line conditions."This would explain why South Dakota is planning to grant exemptions.

Myth #5 – Mining will enrich most local residents.

The truth: most Azarga millions will go to China.

Myth #6 – Current groundwater needs are future groundwater needs.

The truth: it is common knowledge that groundwater is being over-mined and levels are rapidly dropping throughout the west. Tree rings indicate droughts can last up to 30 years or more. Edgemont recently received an outside grant just to update water treatment.

If overlying fresh groundwaters drop and also become contaminated, as Duke University suggests is possible, current system updates could become a joke.

Oglalla Sioux Tribe; the use of outdated science; and insufficient groundwater restoration plans.

Many in Crawford are scared, especially those running their own businesses. They speak of CBR employees visiting their businesses to give reminders of their patronage, advising they avoid the hearing.

The Sisterhood of Sacred Water was inspired by the success of others, including White Plume and the Clean Water Alliance, who are fighting off efforts by Powertech/ Azarga to open a uranium mine near the Black Hills, north of Edgemont.

According to White Plume, "The uranium corporation has been here long enough to embed itself in the community as an economic support, while holding people in economic bondage in terms of choosing between a job and fresh, uncontaminated water." She says that there are other ways to get energy, including wind, solar and industrial hemp, but there is no way to filter radiation in water.

The Atomic License Board expressed dismay over the lack of tribal consultation, faulty cultural site surveys, and use of outdated science by uranium mining "experts" (some geological models were from 1937).

The Press is the Enemy

The Hot Springs *Star*, dated April 4, 2017, ran this guest editorial: "We are NOT the enemy," by Letti Lister of the Black Hills *Pioneer*. Lister defends the press as working hard to report factually, accurately and in a fair and unbiased manner, to allow readers to form their own opinions. Bull manure—the press is generally lazy, liberal, biased and irresponsible.

Witness the Rapid City *Journal* Editorial Board commentary (4/2/17) based on misinformation from *Star* Editor John Taylor's

reports about the March 21, 2017 Fall River County Commission Meeting: "After meeting in executive session and with no public input, the Fall River County Commission voted to allow guns into its courthouse except on days when court is in session."

Taylor later persisted in misinforming the public: "...Taylor disputed Nabholz's claim

that The [sic] Star got it wrong...," claiming that the *Star* simply wrote "...that executive sessions were held, then the weapons issue was approved" (4/11/17).

The truth? *There was no executive session prior to the gun issue vote.* And Taylor knew that.

Furthering the confusion, Taylor continued: "Also, Rick Kaan, of Hot Springs... told the commissioners that the meeting room door was shut following the executive session, and that the public was not invited back into the meeting until [Fall River County State's Attorney Jim] Sword opened the door to let people back in."

How would Kaan know this? He apparently wasn't present, neither immediately before nor after executive session, when the door was opened.

The majority of the reporters on and opponents of in-situ uranium mining do not have the educational or experiential background to either understand nor properly explain the issues involved. And, they have not taken the time to educate themselves. The clearest proof of that was displayed at the Western South Dakota Hydrology Conference in Rapid City on April 6, 2017.

None of them showed up to give a presentation on the risks of uranium mining to the assembled PhDs, geologists, hydrologists, and engineers. Why? Because their arguments do not stand up to critical review by experts.

So, shouldn't the reporters and opponents have shown up en masse to avail themselves of the free conference and to learn the facts? Only if they wanted to know the facts, which apparently they don't.

After Research Scientist Martin Dangelmayr gave his talk on Uranium Attenuation at a former ISR [In-Situ Recovery] facility, only Mark Hollenbeck (Powertech) and I were grilling Dangel-

How can *you* know the truth? Check the 3/21/17 meeting minutes, published in that same April 11 *Star*, written by Auditor Sue Ganje and approved by all five commissioners. The gun issue was publicly discussed during the 9:20 agenda item: "Consider carrying of weapons in the courthouse/courtroom." The motion to allow guns was then tabled, pending Judge Jeff Davis' 10:45 discussion on courthouse security. The gun motion was brought back up, discussed, and passed after the 11:50 agenda item and *prior* to going into executive session at 12:30.

By then, the only people remaining were the auditor, the five

commissioners and the state's attorney. After executive session, at 12:46, Sword opened the door and looked for anyone present; no one came in and we passed a motion to bid.

As neither Taylor nor Kaan were present immediately prior to nor after executive session, they can only offer hearsay. Since Taylor left early, he had a responsibility to

thoroughly research the facts before reporting.

I met with Taylor the day after the meeting and emailed him the now-proven order of events. Perhaps Sword misled Taylor, but Taylor failed to confirm Sword's statements with the other six people present at the meeting.

Were they discouraged by no reports of new plans for more coal fired power plants? Or maybe they were discouraged by reports of low numbers for employment in the coal industry. Engines may have been discouraged by employees saying they didn't need as many engines for normal freight hauling.

What really probably threw the engines into a nearly hopeless depression was a report in Forbes magazine after the 2016 elections: it claimed eliminating one third of operating coal fired power plants would be the cheapest way of cutting CO2 emissions. It also claimed mercury air toxic standards were the reasons for about 30% of the coal capacity that was retired in 2015.

Other problems Forbes cited are current federal subsidies for competing fuels, and retroactive vetoes of mining permits. If things remain unchanged, the magazine said 60 coal fired power plants nationwide would be retired. This ignores the \$130 billion in environmental upgrades by the industry since 1990.

It's all very discouraging: after all, what can one small engine do?

Scientists have confirmed the existence of cannabinoids and of the endocannabinoid system in the human body.

For 50 years, the U.S. National Institutes of Health (NIH) had been funding an Israeli cannabis researcher named Raphael Mechoulam. He was the first person to isolate the structures of THC and CBD and to test the medicinal properties of THC, finding it triggered the endocannabinoid system. The original plat stretched from present C to H streets and from the railroad to 4th Avenue. Several additions were made in later years.

In spite of the railroad's presence during the '90s, local mail was carried by stagecoach from Buffalo Gap to Edgemont with stops in Hot Springs and Wind Cave.

In 1890 a short-lived woolen mill was built, but in the late 1890s, trouble began. Money from the east dwindled as a result of the financial panic of 1893. A number of railroads went into receivership or considerably cut back their expansion into new territories as a result of overextended growth.

Five hundred banks closed, 15,000 businesses failed and farms went under. The problems spread across the country and Edgemont was not spared.

A fire in the late 1890s destroyed most of the business district and disease outbreaks of typhoid and smallpox took its toll. The town center was rebuilt and Edgemont experienced rapid growth for a time.

In 1903, Edgemont was visited by President Teddy Roosevelt. The bandstand where he spoke still stands in the city park.

By the 1930s and '40s, most of the rail traffic in the US was changing from steam to diesel. Many towns created by the railroads suffered economically from this as the new diesels required less maintenance and fewer personnel to keep running.

Water was no longer a requirement for the new engines so they could run through many of the towns where they previously stopped. Edgemont continued as a stop because of the depot.

During and after World War II, the munitions depot south of town known as Igloo helped Edgemont grow, as the town provided services such as grocery stores, bars and car dealerships. There was a pharmacy in town and a hotel. Times were good once again. With the closing of Igloo in the '60s, Edgemont again declined. As the town grew, additions were made. With each addition, the boundaries changed.

Today, there is a map at City Hall showing the boundaries of Edgemont. In fact, there are three separate boundary lines around the town. There is the area the town itself considers its inclusive area, there is the boundary line the State has defined, and a third boundary considered to be Edgemont by the federal government. A current theory is that at the time the maps were digitized, an error occurred.

The question is, which boundary line is correct? This question is one the outgoing mayor tackled. The ramifications are not huge, but there is a question of taxation.

The federal and state governments grant funds (i.e., return tax money) to cities in quantities determined by the size of the entity. Not knowing the proper boundaries could mean the town gets less or more, depending on whose definition is used.

If you live at the edge of town, is your property partially in and partially out of the town limits? No one knows.

So for now, Edgemont is three towns, depending on whose definition you use.

and corruption existing in educational institutions and scientific bodies.
